TIMOTHY C. SULLIVAN is a partner in the Litigation Department of Taft Stettinius & Hollister LLP, where he has practiced since 1986. Mr. Sullivan has litigated more than 120 cases through trial before juries, judges, magistrate judges, referees, and arbitrators in courts throughout Ohio and the Midwest. He has appeared before dozens of arbitration panels, and has often participated with clients in the mediation of disputes with the aid of third-party mediators. Mr. Sullivan has served as an Instructor of Trial Practice at the University of Cincinnati College of Law, and has lectured at several seminars.
