DIRECTIONS:

From the South: Take I-65 North to the Washington Street exit. Take a slight left on the exit ramp onto East Washington Street. Turn right on North Delaware, then a left on Ohio Street. The parking garage and building will be on your right between Delaware and Pennsylvania Streets.

From the North: Take I-65 South to the Meridian Street exit. Turn right on Meridian Street. Take a left on North Street and then a right on Pennsylvania Street. Turn left on Ohio Street and the parking garage and building will be on your left between Delaware and Pennsylvania Streets.

From the East: Take I-70 West toward the Michigan/Ohio/Fletcher Streets exit. Merge onto I-65/I-70 West and take the Ohio Street exit. Stay on Ohio Street and cross Delaware Street. The parking garage and building will be on your right between Delaware and Pennsylvania Streets.

From the West: Take I-70 East to the Illinois/McCarty Street exit. Take the McCarty Street ramp and turn right. Take a left on Delaware Street and a left on Ohio Street. The parking garage and building will be on your right between Delaware and Pennsylvania Streets.
