Directions to Phoenix

From US 60 West:

Follow US 60 West to the I-10 West/US 60 West exit towards Phoenix. Follow I-10 West to Exit 147A-B. Merge onto AZ-51 North. Follow AZ-51 to Exit 4A Highland Avenue/Camelback Road, and turn right onto East Highland Avenue from the ramp. From Highland Avenue, turn left onto North 22nd Street, then turn right onto East Camelback Road.

Our building is to the right, just before 24th Street. Pull into the building area and follow the entrance road past the 30 minute parking area. The parking garage will be on your right.

From I-10 East:

Follow I-10 East to Exit 147A-B. Merge onto AZ-51 North. Follow AZ-51 to Exit 4A Highland Avenue/Camelback Road, and turn right onto East Highland Avenue from the ramp. From Highland Avenue, turn left onto North 22nd Street, then turn right onto East Camelback Road.

Our building is to the right, just before 24th Street. Pull into the building area and follow the entrance road past the 30 minute parking area. The parking garage will be on your right.

From AZ-51 South:

Follow AZ-51 South to Exit 4A Colter Street/Camelback Road, turning left onto East Colter Street from the ramp. Follow the curve right, the road becomes North 18th Street. From North 18th Street, turn left onto East Camelback Road.

Our building is to the right, just before 24th Street. Pull into the building area and follow the entrance road past the 30 minute parking area. The parking garage will be on your right.

From AZ-51 North:

Take AZ-51 North to Exit 4A Highland Avenue/Camelback Road, and turn right onto East Highland Avenue from the ramp. From Highland Avenue, turn left onto North 22nd Street, then turn right onto East Camelback Road. Our building is to the right, just before 24th Street. Pull into the building area and follow the entrance road past the 30 minute parking area. The parking garage will be on your right.

From Sky Harbor International Airport:

Follow East Sky Harbor Boulevard out of the airport to I-10 West. Follow I-10 West to Exit 147A-B. Merge onto AZ-51 North. Follow AZ-51 to Exit 4A Highland Avenue/Camelback Road, and turn right onto East Highland Avenue from the ramp. From Highland Avenue, turn left onto North 22nd Street, then turn right onto East Camelback Road. Our building is to the right, just before 24th Street. Pull into the building area and follow the entrance road past the 30 minute parking area. The parking garage will be on your right.

From Scottsdale Municipal Airport:

Take North Airport Drive to East Butherus Drive. Continue on East Butherus Drive as it becomes East Greenway Parkway and then East Greenway Road. Merge onto AZ-51 South via the ramp on your left. Follow AZ-51 to Exit 4A Colter Street/Camelback Road, turning left onto East Colter Street from the ramp. Follow the curve right, the road becomes North 18th Street. From North 18th Street, turn left onto East Camelback Road. Our building is to the right, just before 24th Street. Pull into the building area and follow the entrance road past the 30 minute parking area. The parking garage will be on your right.
