### Directions to Cincinnati

#### From Cleveland:

Take I-90 West to I-71 South towards Columbus. Travel southbound on I-71 for 245.2 MI. Merge to the far right lane as you approach Cincinnati. This lane becomes the Downtown/RiverFront/3<sup>rd</sup> Street exit. After you go through the tunnel, stay in the center lane as you travel west on 3<sup>rd</sup> Street. Proceed 5 blocks (.6MI). Move to the far right lane after crossing Walnut Street. Turn right on Vine Street and stay in the right lane (our building is on the right). After crossing 5<sup>th</sup> Street, turn right into the Fountain Square parking garage.\*  
Total Distance: 250 MI  
Total Estimated Time: 4 Hrs. 16 Min.

#### From Columbus:

Merge onto I-70 West. Take the I-71 South Exit, Number 99-a-B on the left towards Cincinnati/Dublin Road. Merge onto I-71 South. Travel Southbound on I-71 for 103.8 MI.  
Merge to the far right lane as you approach Cincinnati. This lane becomes the Downtown/RiverFront/3<sup>rd</sup> Street exit. After you go through the tunnel, stay in the center lane as you travel west on 3<sup>rd</sup> Street. Proceed 5 blocks (.6MI). Move to the far right lane after crossing Walnut Street. Turn right on Vine Street and stay in the right lane (our building is on the right). After crossing 5<sup>th</sup> Street, turn right into the Fountain Square parking garage.\*  
Total Distance: 106.8 MI  
Total Estimated Time: 1 Hr. 54 Min.

#### From Dayton:

Travel southbound on I-75 for 51.2 MI. take the I-71 North Ramp (.4 MI). Take West 5<sup>th</sup> Street/OH-264 East exit. West 5<sup>th</sup> Street becomes 5<sup>th</sup> Street East (.3 MI). After crossing Vine Street, turn right on Walnut Street, then turn right on 4<sup>th</sup> Street, then right again on Vine Street and stay in the right lane (our building is on the right). After crossing 5<sup>th</sup> Street, turn right into the Fountain Square parking garage.\*  
Total Distance: 53.9 MI  
Total Estimated Time: 60 Min.

### **From I-71 South:**

Travel southbound on I-71. Merge to the far right lane as you approach Cincinnati. This lane becomes the Downtown/RiverFront/3<sup>rd</sup> Street exit. ### **From I-74 East:**

Take I-74 East and merge onto I-75 South toward Lexington (3.7 MI). Take the 5<sup>th</sup> Street exit on the left (.3 MI). Merge onto 5<sup>th</sup> Street East (.4 MI). After crossing Vine Street, turn right on Walnut Street, then turn right on 4<sup>th</sup> Street, then right again on Vine Street and stay in the right lane (our building is on the right). After crossing 5<sup>th</sup> Street, turn right into the Fountain Square parking garage.\*

### **From Columbia Parkway:**

Follow Columbia Parkway to 6<sup>th</sup> Street East. Turn left onto Walnut Street (.2 MI). Turn right onto 4<sup>th</sup> Street, then right onto Vine Street, staying in the right lane (our office is on the right). After crossing 5<sup>th</sup> Street, turn right into the Fountain Square parking garage.\*

### **From Northern Kentucky**

#### **I-71/I-75 North:**

Take I-71 N/I-75 N into Ohio. Immediately after crossing the river, merge onto I-71 N and take the 2<sup>nd</sup> Street Exit. Proceed Four blocks East and turn left on Vine Street. After crossing 5<sup>th</sup> Street, stay in the right lane and turn right into the Fountain Square parking garage.\*

#### **I-471 North:**

Take 471 N. across the bridge and take the 6<sup>th</sup> Street exit - exit number 6B - toward downtown. (.3 MI). Stay straight to go onto 6<sup>th</sup> Street East (.2 MI). Turn left onto Walnut Street (.2 MI). Turn right onto 4<sup>th</sup> Street, then right onto Vine Street, staying in the right lane. After crossing 5<sup>th</sup> Street, stay in the right lane and turn right into the Fountain Square parking garage.\*
